Budgeting works according to goals. These are mostly set on revenue or number of customers.

Setting a sales target at the beginning of the year makes sense for any company, regardless of size. For larger companies, there are sales targets by department, for startups it is total sales. After goals are set, you determine in the budget plan the effort you need to generate in order to reach these sales goals.

Once the goal has been set, the question arises as to which resources are required in what amount in order to achieve this goal.

These can be expenses for advertising or personnel, whereby one breaks down the costs for these. For example, hiring employees involves recruiting expenses. So in budgeting, you plan for the big expenses and investments.

Performed annually, you will be able to forecast for the next year based on the data from the previous period.
