

# Public Safety Commission Meeting October 18, 2011, 9:30 a.m. Criminal Law Enforcement Auditorium 6100 Guadalupe, Bldg E Austin, TX 78752

# Summary

(This report represents a summary of events of the meeting, and is not necessarily complete nor an exact transcript of testimony.)

The Public Safety Commission convened as posted to consider and take formal action, if necessary, on the following agenda items:

#### I. CALL TO ORDER

9:42 am - Chairman Polunsky called the meeting to order. In attendance: Chairman Allan Polunsky, Commissioners Carin Barth, John Steen and Cynthia Leon. Commissioner Ada Brown was not present. Also present were Deputy Director David Baker, and General Counsel Phil Adkins. Director Steve McCraw arrived later in the morning.

#### II. APPROVAL OF MINUTES

Motion made by Commissioner Barth, and seconded by Commissioner Leon, to approve the Minutes. Approved – Commissioner Steen abstained since he was not in attendance.

**III. PUBLIC COMMENT** (members of the public wishing to address the Commission are subject to a time limit of 5 minutes and must complete a Public Comment Registration Card located at the entry)

Chairman Alan Polunsky asked if anyone wished to make public comment. There was no response.

# IV. DIRECTORS REPORT

Director Steve McCraw is in San Antonio and will move this report until later in the meeting.

12:00 noon – Director Steve McGraw introduced FBI Special Agents to issue an award

#### A. FBI Presentation

Federal Bureau of Investigation (FBI) Special Agents Michael Bonner, Mark Kelley and one other agent presented a Certificate of Commendation to Texas Ranger Louis Jeffrey Owles who, on April 8, 2011, while an Agent

with the Departments Criminal Investigation Division, was working with the FBI's Multi Agency Gang Task Force and provided tactical support for an operation to rescue two adults and one child being held captive by very well armed kidnappers known to be connected with the Mara Savatrucha (MS-13) gang. Later investigations found that the victims were to be moved and killed one hour after the law enforcement interdiction.

### V. NEW BUSINESS

**A.** Discharge Appeal Hearing and possible action regarding DPS employee Juan Lozano. Chairman Polunsky –instructed Counsel Frank Menchaca regarding this hearing as being an administrative hearing and not subject to the same rules of a court proceeding. The hearing began at 9:47 am. Counsel Jeff Lopez represented the Department.

Following two hours of testimony, a motion was made by Commissioner Leon to uphold the termination. The motion failed for lack of a second.

Commissioner Barth moved to postpone the appeal hearing decision to a future meeting. Seconded by Commissioner Steen. Motion carried 3-1, with Commissioner Leon voting against. Commissioner Steen asked if it is permissible to discuss the hearing in Executive Session. Gen. Counsel Adkins confirmed that that was permitted.

**B.** Report, discussion, and possible action by the Commission regarding the appointment of members to the Vehicle Inspection Advisory Committee under Transportation Code, section 548.006

Assistant Director Renearl Bowie – Regulatory Division – made a recommendation to add a member to the VIAC. Motion made and seconded. Approved unanimously.

C. Discussion and possible action to authorize the Director to execute a deed conveying 0.0156 acres of real property for highway purposes in Rosenberg to the Department of Transportation under the authority of Transportation Code, Section 203.055

Assistant Director Valarie Brown – Administration Division – This is a small plot (1/16<sup>th</sup> acre) that is not developable and needs to be transferred for highway improvements. Motion made and seconded. Approved unanimously.

## **D.** Briefing on the "Texas Science and Engineering Festival"

Assistant Director Rebecca Davio – introduced Deputy Assistant Director Enrique Gomez who founded the "Texas Science and Engineering Festival" last year before joining the Department. DPS will participate in this year's festival to showcase and promote science and technology in Texas. This year's event will be held on Nov. 5-6, 2011, at the Austin Convention Center, and is free to attend. It is the second largest festival of its kind in the U.S. Last year there were over 20,000 attendees and over 100 booths and 17 sponsors. This is an excellent opportunity for the Department to engage the public and show a different face of law enforcement.

**E.** Report, discussion and possible action regarding the adoption of proposed new Capitol Access Pass Rules: Rules 2.1 – 2.13, 37 TAC Secs. 2.1 – 2.13, concerning the establishment of rules for Capitol Access Pass

AD Renearl Bowie proposed adoption of the rule as published in the Texas Register. This will be similar to the Concealed Handgun Licensing process without the need to complete the handgun training. Motion made and seconded. Passed unanimously.

F. Report, discussion and possible action regarding the adoption of amendments to Commercial Driver License Rule: Rule 16.2, 37 TAC 16.2, concerning Commercial Motor Vehicles and Licensing Definitions

AD Rebecca Davio – These are rules that we reported to the Commission several months ago. They have been posted in the Texas Register and we had no comments. Motion made and seconded. Passed

Regarding FTE's, we have 368 vacancies, with 60 recruits in the current class which will leave 308 FTE's needed.

We have a total of 469 applicants that have been pre-screened.
