FACTS	WHAT DOES CONSERVATION RESOURCE PARTNERS, LLC DO WITH YOUR PERSONAL INFORMATION?	
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the products or services you have with us. This information can include: • Social security number and income • Wire transfer instructions, email addresses, and physical addresses • Net worth and investment experience When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information, the reasons Conservation Resources chooses to share, and whether you can limit this sharing.

	 Conservation Resource's nonaffiliates include custodians, administrators, and third-party investment managers, and broker- dealers. 				
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.				
	Conservation Resource does not jointly market with nonaffiliates.

State Laws: We will automatically limit the sharing of your information in accordance with applicable state law.

For California Residents Only: We will not share information we collect about you with non-affiliated third parties, except as permitted by California law, such as to process your transactions or to maintain your account. We will limit sharing among our companies to the extent required by California law.
