A Colorado Sheriff's Deputy Turned to Adult Film Industry Amidst Financial Desperation Ms Lofland's financial struggles began after a June 2023 hailstorm caused \$500,000 in damage to her home — expenses her insurance wouldn't cover. Her finances were affected by a \$500,000 hail and water damage bill, which left her without insurance coverage; tripled interest rates on her mortgage led to foreclosure; and increasing utility costs pushed her into cutting expenses. Shannon Lofland, a 44-year-old driver training instructor at the Arapahoe County Sheriff's Office in Colorado, has resigned after 21 years of service due to her secret career in the adult film industry being exposed. Lofland turned to performing in adult videos as a means to support her family financially, having struggled with debt and rising living costs. Despite knowing that her side gig was against department policy, she felt it was necessary to save her home and provide for her loved ones. After her suspension, Lofland chose to leave her position to avoid wasting department resources on an internal investigation.
