Given article text here Since we are new to this partnership, some revisions are likely unavoidable as we navigate our relationship. With Lady Larkspur discovering about FLR, we reviewed the agreement and found additional aspects that hadn't been considered during the initial signing. Relationship Agreement Preamble Lady Larkspur and BT agree to this partnership on November 12, 2014. The man's role is to support her decisions. Clarification of Responsibility / Control Lady Larkspur will manage finances, free time, sexuality, household chores, and life direction. BT will handle his designated areas with veto power over decisions involving dependents and children. Conflict and Change They agree to resolve conflicts through conversation first. If needed, a formal document will be created to register the conflict and remediation. Lady Larkspur has final say in all matters. As we move forward, both parties are committed to learning from our conflict and making adjustments to this agreement to minimize future disagreements. In the event of non-compliance, we agree on a remediation process. This involves acknowledging the issue, reviewing the agreement where it occurred, and implementing any necessary consequences. After addressing the problem, we can reassess and make amendments if needed, especially at the request of the party not responsible for the mistake. If the affected party refuses to accept full remediation, this agreement will be considered null and void. In terms of non-performance penalties for BT (the man), Lady Larkspur may assign demerits as she sees fit. These demerits can be cancelled through various means at her discretion, including physical punishment or forfeiting privileges like gaming or internet use. The specific penalties are outlined below: - One demerit is canceled with two strokes of the cane. - One hour of vigorous physical activity cancels one demerit. - Two demerits require a 24-hour loss of gaming privileges for BT, excepting time on . - Four demerits result in 24 hours without internet privileges, except for writing-related research. However, access is limited to two hours with strict supervision. - Five demerits lead to a complete loss of internet privileges, including social media use, restricted to writing-related activities only. If the offense is severe enough that Lady Larkspur loses confidence in her leadership, she can dissolve this agreement. Conversely, if BT's non-performance causes him to question her ability to lead, he can also request dissolution. For maintaining a healthy relationship, we agree on several key points: - We will ensure time each evening for joint activities like watching TV or playing cards with tea. - Regular physical activities and quality time spent together outside the house are crucial for our growth as individuals and as a couple. These include bike rides, long walks, and other exercise routines. We also plan to celebrate certain holidays, ceremonies, and traditions (listed in the attached document), which hold significant value to us both. Lastly, we agree to adhere to specific financial rules: - Lady Larkspur will manage all family finances, making decisions on how funds are allocated. - BT will hand over his credit/debit/ATM cards for her to oversee and use as necessary. On payday, they will review the budget together, with Lady Larkspur assigning priorities for spending. - After their review, any unused funds not needed for essential expenses like rent or utilities will be given to Lady Larkspur for distribution according to her discretion. --- Lady Larkspur will provide BT with a set amount of money each week, for which he will not be accountable. Daily tasks include emptying the dishwasher, dish drainer, litter boxes, and maintaining a clutter-free desk area. Weekly tasks comprise vacuuming the house, cleaning toilets and showers, recycling, trash management, and small trash can emptying. BT will complete ad-hoc tasks as assigned by Lady Larkspur on the kitchen whiteboard. He will verify task completion with a check mark and let Lady Larkspur erase completed tasks. In matters of sexuality, BT surrenders control of his orgasms to Lady Larkspur, who decides when, where, and how they occur. BT may request intimate activities, but must abide by Lady Larkspur's decisions and be available for any activity she desires, considering his work schedule.
