## Linda de sousa video leaked

A former prison officer at HMP Wandsworth has been sentenced to 15 months in prison for having sex with an inmate while on duty. Linda De Sousa Abreu, 30, was caught after a video of the incident went viral online and was identified by senior prison staff. She had previously pleaded guilty to misconduct in public office. The court heard that Abreu had also performed a sex act on her body-worn camera, which was found during an investigation. The governor of Wandsworth Prison described Abreu's actions as having "taken less than a day" to undo the hard work of female staff at all-male prisons. Linda De Sousa Abreu, a public officer at HMP Wandsworth prison, was charged with misconduct after engaging in a sexual act with an inmate in a prison cell between June 26-28. The shocking footage, which has been widely shared on social media, shows her initially engaging in what appears to be a sex act with the criminal, followed by having sex with him while his cellmate films on a mobile phone. Colleagues are heard on the officer's radio as she is seen interacting with the prisoner and his cellmate. De Sousa Abreu was jailed for 15 months after pleading guilty to the charge. The judge stated that although she may not have intended it, the video went viral and caused great harm. He emphasized that there is no excuse for prison officers who abuse their position of power. By judge when passing sentence, Abreu was found guilty of two incidents involving sexual intercourse with prisoners at HMP Wandsworth. She claimed to have acted under duress but her account had been proved false. The court heard that she had a previous conviction and had not made any complaints about incidents involving her. Abreu's defense team argued that she had taken full responsibility for her actions, acknowledging the consensual nature of the encounters and her role in allowing them to be filmed. However, the prosecution emphasized the deliberate planning behind the acts, highlighting how Abreu had undermined the authority of prison staff and compromised the trust of prisoners. The court heard that Abreu's actions had undone years of positive interactions between female prison officers and male prisoners at HMP Wandsworth. A prison guard at HMP Wandsworth has admitted to misconduct after being caught on camera having sex with an inmate. Linda De Sousa Abreu, 30, faces a jail sentence for breaching the public's trust. The incident occurred in June when De Sousa Abreu was recorded by her cellmate having sex with inmate Linton Weirich, 36. The footage shows De Sousa Abreu engaging in a lewd act while her radio crackled with messages in the background. She has pleaded guilty to one charge of misconduct in public office and will face sentencing on November 7. Linda De Sousa Abreu, a 30-year-old prison officer from Fulham, south-west London, has been charged with misconduct in public office after disturbing footage of her engaging in a sex act with an inmate surfaced at HMP Wandsworth. The inmate, Linton Weirich, is serving four years and nine months for burglary. De Sousa Abreu pleaded guilty to the charge during a hearing at Isleworth Crown Court today. She was arrested on suspicion of misconduct in public office at Heathrow Airport after the footage, filmed by another inmate using an illegally-held phone, circulated among prisoners. The CPS described the incident as a "shocking breach of the public's trust." Wandsworth prison officer Linda De Sousa Abreu, 31, has been sentenced to 15 months in prison for misconduct. The married mother-of-one had previously admitted to having an affair with a male inmate at the prison. This comes after footage emerged of her and her husband participating in a swingers show on Channel 4, where they discussed their open relationship and engaged in explicit acts. De Sousa Abreu also ran an OnlyFans account under pseudonyms "Linda from the Playroom" and "La Madre", where she charged fans for explicit content. Linda De Sousa Abreu, a woman who claimed to have found faith in God after an incident, has been sentenced to 15 months in prison but is likely to serve less time. The inmate involved in the incident, Weirich, was caught on video having sex with De Sousa Abreu while he had a pregnant girlfriend. De Sousa Abreu's OnlyFans account shows explicit content and her profile claims she shares "real life, real love, real sex and real orgasms." Any incident involvin her woulda been bad news. The crown says theres premeditation and clear planin involved. She needed to be alone with him, and arranged for the other prisoner to keep watch while it went down. We say the act was deliberate and intentional in terms of planning... an intentional breach of her duties as a prison officer. She had the right trainin and knew what her duties were, but she still undermined the authority of all prison staff - specifically and severely underminin the positive effect a female officer can have in a male environment. She also undermined the trust of prisoners and the integrity of the staff. De Sousa Abreu was a prison officer at HMP Wandsworth when the explicit footage was recorded - her friend claimed she was coerced into doin so by prisoners. Linton Weirich is the inmate who was filmed havin sex with a female guard in a cell, and he's got a partner. The judge told Abreu that she'd be gettin 15 months imprisonment, servin half in custody unless released earlier. She'd already been subject to a qualifying curfew for 190 days, which entitled her to a credit of 95 days against the sentence. The judge noted that many offenders don't intend the harm their offending causes, but they still bear responsibility for it. He also mentioned that prison officers have faced hecklin and harassment since the video went viral, with children of fellow female prison officers gettin teased about what their moms might do at work. The judge said that the damage caused by Abreu's actions would likely spread through the prison estate, impactin the reputation of the prison service, and causin anxiety among those close to vulnerable prisoners. Prison officer De Sousa Abreu faces charges over alleged relationship with inmate De Sousa Abreu completed a 'counter corruption' training course in April but allegedly compromised it by engaging in a consensual sexual relationship with an inmate, Weirich, at Wandsworth Prison. The action of the defendant has undermined years of positive relationships between female staff and prisoners, leading to concerns over the safety and well-being of both staff and inmates. Staff reported being subjected to harassment and heckling from prisoners, while some officers were even teased by their children for working at the prison. De Sousa Abreu faces charges over the alleged relationship, which has sparked concerns about the recruitment and retention of female staff in the prison service. The incident highlights the need for high standards of professional conduct among prison officers, who are expected to maintain a safe and respectful environment for both prisoners and staff. Mr Menon stated he fully accepts the responsibility for his impulsive behavior and deeply regrets breaching trust while serving. He requested a suspended sentence for Ms Abreu, who suffers from severe personality disorder, ADHD, making her highly impulsive and reckless. A psychiatrist report described her as emotionally damaged, using sex to cope with emotions. Menon argued that her mental disorder should reduce culpability in this case. Her life was crumbling, leading to the decision to leave the country for a few weeks during the media storm. Friends claim she was under pressure from her lifestyle and work, affecting her marriage. The UK has charged a female prison officer, Linda De Sousa Abreu, with misconduct after she was caught on video having sex with an inmate in a men's jail. Prosecutors say the incident will be subject to further investigation. The correctional officer, married and apparently a swinger, had been working at HMP Wandsworth prison when the alleged abuse of trust occurred.
