

Imsha rehman viral video leak

Pakistani TikTok sensation Imsha Rehman has broken her silence over a scandalous video that left her reeling. Following the alleged leak, she went into hiding and shut down her social media accounts. In an exclusive chat with Nukta Pakistan, Imsha accused the viral clip of being "totally fake". "When I saw it, my whole world came crashing down," she confessed. "I couldn't step foot in university, face people or even get through a day without death threats."
